

# MVP Sports & Social Special Event

This group would like to use the RW volleyball courts on Wednesday evenings for 9 weeks beginning on February 8, 2017 – April 12, 2017. (Refer to details in attached letter – the groups are staggered by times.) As our courts currently do not have lights for nighttime play, they would bring in their own lighting which would be powered by generators.

The rental fee schedule in our manual states the courts can be rented for \$75/day. As this is a situation in which they are providing lighting to use the courts at a time when they would otherwise be unusable, they have requested to have the fee reduced to \$30/night – the amount the county formerly charged them to play at Tom Bennett Park.

## Quote from Organizer:

“We run this league 3-4 times a year and are looking for a permanent home for it here in Bradenton. However, moving forward we won't be able to turn a profit with that high of a court fee. We would have to relocate to the Bee Ridge courts in Sarasota which are \$10.00/night and already have lights. It has always made more sense for us to go there because they have the lights, but we want it to be in Bradenton so much we've done everything possible to keep it here; like putting up and taking down our own lights each night. Anything you can do to help us is very much appreciated.” - Chris McComas, MVP Sports & Social

Hi Rene,

My name is Chris McComas and I am the owner of MVP Sports and Social. I am in search of 2 sand volleyball courts to run our social volleyball league on Wednesday evenings. We have been running this league in East Bradenton at Tom Bennett Park, but we were recently informed that the park will be closing at dusk once the temporary fire station, which is currently in the park, moves to it's final location outside of the park. This is a very popular league to the Bradenton community and the winter session has already been sold to several returning as well as new players. Because of this very untimely news that our courts are no longer available we are left scrambling to find a home.

We feel the Bradenton Riverwalk courts are the perfect solution as the park is 24 hours and it keeps this beloved league in the city of Bradenton. We are fully equipped to put up and take down temporary lights for the courts during the winter months. We have attached a video of some game play at Tom Bennett Park to show you what the temporary lights look like.

When we played at Tom Bennett Park we paid \$30.00 a day (an evening) to reserve the courts. We have budgeted \$30.00 a day for court rentals and believe this is a fair price. We will need the courts for 9 weeks. One "open night" from 6:30pm - 8:30pm on Wednesday, February 8th. Then 8 weeks straight beginning Wednesday, February 22nd - Wednesday, April 12th.

## Rental Contract
